## HANDLOADING FOR THE .44 AMP

The .357 and .44 AMP's are hunting handguns, make no mistake. The AMP's were designed to offer the maximum performance in a hunting handgun, with modern jacketed pistol bullets, operating between 1450-1800 f.p.s. at 42,000 to 48,000 c. u.p.'s. For those individuals wanting to use lead bullets and mid-range loads in their Auto Mags, forget it. The revolver and the .45 ACP were designed for lead bullets and reduced loads.

Thus, the AMP becomes a highly sophisticated piece of ordnance for the handgun specialist, and when handloading for either caliber, it should only be undertaken by the experienced handloader. The AMP owner/handloader should approach the task of handloading the AMP calibers like he is loading for a rifle, rather than a handgun.

The fast burning double-base propellants, such as Bullseye and Unique, are virtually useless; as their pressure curve is too sharp to set up the proper recoil impulse required for proper functioning of the AMP. The optimum loading in either caliber requires the slower burning ball propellants.

While the advanced handloader, or amateur ballistician realizes that the medium fast, double-base propellants cannot offer the optimum pressure/velocity ratio of the ball propellants, he also realizes that for proper iginition and reduced powder residue, the ball powders do not match these medium fast, double-base propellants such as Blue Dot, at temperature ranges below, say 10° - 15° farenheit. Thusly; loads indicated were developed for both

After P & V testing some 15 to 17 canister and non-canister propellants, I have limited the data to the loads listed below as the most practical. The loads using WW 680 in the heavier bullets will really come into their own in the 81/2" and 101/2" barreled 44's. Current production H-110 is an excellent powder and may be substituted for WW 296. If you are not sure of your lot of H-110, start 3.0 grains below those listed using WW 296 and check for functioning in your AMP. I personally have isolated, by P & V testing, three different burning rates of the H-110 during the past six years. If you are fortunate enough to have

some of the H-110 from three to five years ago, save it for the Auto Mags. There is nothing commercially available today to offer it's excellent P & V ratio for magnum handgun loadings. In my personal hunting loads I was getting 2000 plus f.p.s. with the 6½" barrel at 49,000 c.u.p.'s with the faster burning lots of H-110.

All loads listed below were fired from a 6½" P & V barrel; using new CDM cases and CCI#350 primers. As the .44 AMP headspaces on the case mouth, check and/or trim all cases to 1.298" - 1.296". When using cases formed from 7.62 or .308 brass, reduce powder charge by 5%.

Start making plans now to attend the First Annual Auto Mag National Matches, to be held April 25th, 26th & 27th, 1975 near Laredo, Texas. The course of fire for the Auto Mag National Matches will be similar to that of the Mexican Silhouetta Competition; and is designed to promote the sport of hunting with a handgun. Although various clubs have had similar type matches, with handguns as far back as the 1920's -30's, this will be the first competition of it's type on a national scale. This first year's competition will be limited to the Auto Mag handguns only, however plans are in the offing to include any magnum caliber handgun suitable for hunting, in future competitions.

Col. Charles Askins, Director of Competition and Col. Evan Quiros, Match Host, report to me that plans are set for the matches to be held on Friday the 25th, Saturday the 26th and Sunday the 27th in April. Friday, the first day, will be given to warm-up matches over the entire course. This will be 75 meters, 125 meters, 150 meters and 200 meters. The Saturday and Sunday portion will be given over to the National Match firings. This will make 20 shots at each target and at each range for the two days of record firing. Thus, there will be a:

Champion 75 meter (gallo) 125 meter (javelina) Champion Champion 150 meter (guajalote) 200 meter (oso) Champion

The overall champion will have the highest aggregate score for the two days of record firing. He will then be the National Auto Mag title holder.

The Director of Competition is Col. Charles Askins #196, and hosting the First National Matches on his "Shipp" Ranch, is Col. Evan Quiros # 041. Reservations for shooters and family will be made at the La-Pasada Inn in Laredo on the banks of the Rio Grande, "where those interested can walk over the bridge to the land of the Manana". A noonday meal will be catered to the Shipp Ranch each day. A mini-bus will be set up for those competitors who fly into Laredo and need transportation to and from the Shipp Ranch. Entry blanks and reservation forms will be mailed to all Club Members, and/or interested parties. Serving with Col. Askins in a supporting manner will be George C. Nonte # 007 and J. D. Jones # 005. A parts supply, tune-up tent and servicing department will be handled by Harry Sanford # 003 and Kent Lomont # 004. Yours truly will serve as staying out of their way.

Trophies will be awarded to each yardage champion as well as the Grand Aggregate or National Championship Trophy. Portions of the entry fee will be returned to the competitors as cash awards. It is planned that the first through third places in each event will receive merchandise awards. LEJ

#### EDITOR:

I read with a great deal of interest the September issue of the NEWS-LETTER, especially Mr. J.D. Jones' article on power trimming the .357 AMP cases. I was very happy to see that there is at least one other member of the club who is as lazy as I am. As I am supplying nine standard loads in each Auto Mag caliber, and several special High Velocity Hunting loads for specific hunting applications, I use a great many .308 cartridges that must be lubed, trimmed, reamed, finish-trimmed, deprimed, sized, belled and primed, as well as inside and outside deburred, before charging with powder and seating the bullet. With a great many hand operations to perform on each case, I am always interested in any short cut that will reduce my hand operations without decreasing quality. I have been using a system very similar to the one Mr. Jones suggests for quite some time.

However, I have incorporated some variations that I feel the club members may wish to know about. First. I made the outside diameter of the internally threaded section the same size as the cutter bar so that the entire cutter bar with the drill adaptor attached can be removed by slipping off the snap-ring and sliding it out and then replacing the snap ring. I do this because I have another cutter bar assembly for use by hand. The other difference between my set up and Mr. Jones' is that I obtained a solidstate Motor Speed Control. This allows me to slow my quarter inch electric drill down to about 150 rpm's. This slow speed eliminates any potential lubrication and heat build up problems before they arise, and the difference in actual time spent trimming between full speed of the drill and the lowered speed is very hard to actually measure, because I am eliminating the need of frequent lubrication, and the accompanying necessary clean up.

For the benefit of Club members. I use a Model 10 Motor Speed Control made by International Electronics Co., Ltd. of 2440 Reservoir Ave., Trumbull, CT 06611. While

Add up the cost of guns, ammo, license fees, travel, hunting gear, range fees and the like. Say what you will the amount is considerable. Not only is there a great investment in the equipment, but there is a great investment in the freedom and the enjoyment it provides. Unless you add another expenditure, you may as well kiss guns goodbye. This will be the last year for progunners to unite, organize and fight. Antigunners are working everyday. They are not pushing hard now because legislators are too busy to bother with gun control at the present time. But, they are far from sleeping.
